4 BUILDING MANAGER'S REPORT:

- 4.1 <u>BDR Security</u> A new quote has been obtained from BDR Security for the additional security camera in the carpark and there was agreement for Russell McKinnon to instruct the contractor to proceed with installation.
- 4.2 <u>Lift Signage</u> The Committee will arrange signage relating to the use of the service lift.
- 4.3 <u>Front Door</u> Russell McKinnon is awaiting a quote from AutoDoor to replace the mechanism of the front door which shows a high level of corrosion.

8 GENERAL BUSINESS:

- 8.1 Extension of Consultation Period for New Bus Stop proposal on Quay Street Auckland Transport Mick Webb has spoken with Pippa Mitchell from Auckland Transport who has advised that Auckland Transport are only concerned with the health & safety aspect of a new bus stop for 148 Quay Street. Mick Webb also spoke to Pippa Mitchell about the canopy from a health and safety point of view. Pippa Mitchell was not aware of two of the three incidents in the last few years of buses mounting the pavement and hitting the building. Mick Webb will write to Pippa Mitchell providing more information i.e. dates of incidents and photographs (to be provided by Stephen Dudding to Mick Webb). BCA Ltd is to provide to Mick Webb information on the insurance claims which were lodged for two of the incidents. BCA Ltd to also provide copies of letters / emails to and from Council regarding these incidents to Mick Webb. Dimitri Margaritis was asked to obtain support from an outside party. BCA Ltd is to organise a meeting for Dimitri and Stephen with Mark Lambert (Group Manager at Auckland Transport) for either 29th or 30th January 2015.
- 8.2 <u>Reassessment for Insurance</u> Kwanto are currently working on the reassessment report. BCA Ltd has sent the Building CD Plans to Kwanto. Their timeframe is around three weeks for completion.

The insurance renewal date is 10th March 2015. BCA Ltd is to obtain a preliminary insurance quote from Gregan & Co. based on the current valuation. Once the Kwanto report is supplied, BCA Ltd is find out from Gregan & Co. how much additional premium would be if based on a higher quantum (i.e. as per Kwanto) which would then be tabled at the AGM for a decision from owners. BCA Ltd is to forward a copy of the Kwanto report to the Committee as soon as it is available.

8.3 <u>Ultra Fast Broadband</u> – Chorus are persevering with this. BCA Ltd to obtain an update.
